

Chart Of The Week: Money Talks



EARNINGS

Despite concerns toward US equities being overvalued and overconcentrated, S&P 500 companies continued to deliver from an earnings perspective. Last quarter, they delivered EPS growth of 13% year-over-year, above consensus expectations for 8% – the strongest in over 3 years. We expect this strength in US earnings to continue, supported by resilient growth, consumer spending, and outsized investments in capex and R&D, though tariffs may pose a downside risk.

MARKET SUMMARY

GLOBAL EQUITIES: US equities rose last week following continued strength across corporate earnings for 4Q 2024. Ultimately, the S&P 500 ended the week up 1.52%, despite inflation coming in hotter than consensus expected. Outside the US, the STOXX 600 and FTSE 100 rose 1.83% and 0.45%, respectively, with the former notching an all-time high on Thursday on the back of strong corporate earnings.

COMMODITIES: Oil prices were mixed last week as inventories decreased by less than expected. WTI and Brent crude ended the week at \$70.74 and \$74.74/bbl, respectively, following the International Energy Agency reporting an increase in its forecast for global demand and a decrease in its forecast for Russia supply. Meanwhile, gold prices notched an all-time high on Thursday, ending the week \$2900.70/troy oz.

FIXED INCOME: Global sovereign yields mostly rose last week on the back of President Trump announcing plans to impose reciprocal tariffs on trade partners. In the US, the 2-Year and 10-Year US Treasury yields ended flat at 4.25% and 4.47%, respectively, as Jerome Powell's Congressional testimony noted a meaningfully higher neutral policy rate compared to the last cycle. Outside the US, the 10-Year German bund yield rose to 2.43% amid continued negotiations between the US and Russia for a peace deal with Ukraine.

FX: The US dollar weakened against a basket of currencies last week as rising inflation reflected the continued burden of elevated prices for consumers and their purchasing power. The US dollar index ultimately ended the week down -1.28%. Meanwhile, the pound sterling and euro rose to \$1.2596 and \$1.0500, respectively, with the former rising on the back of above-consensus growth in the UK.

ECONOMIC SUMMARY

INFLATION: Inflation in the US for January came in hotter than consensus expected, strengthening the case for the Fed to cautiously proceed with interest rate cuts for the remainder of this year, if at all. Headline and core CPI ultimately printed at 3.0% and 3.3% year-over-year, above consensus expectations for 2.9% and 3.1%, respectively. This month marks the 45th straight month of core CPI above 3%, the longest period of elevated inflation in the US since the 1990s. Meanwhile, US PPI came in at 0.4% month-over-month for January, above consensus expectations for 0.3%. In China, headline CPI inflation jumped to 0.5% year-over-year in January, mainly due to higher food prices and tourism-related services prices during the Lunar New Year holiday.

MONETARY POLICY: In his testimony to Congress, Powell noted that the FOMC did not need to be in a hurry to adjust its policy stance, especially if the economy remains strong and inflation proves persistent. He also affirmed that the neutral rate is "meaningfully higher" than its pandemic-lows. Our colleagues in GIR continue to expect two more 25 bp cuts in June and December this year and one more in 2026.


POLITICS: On Thursday, President Trump announced plans to develop a "Fair and Reciprocal Plan" for trade, which seeks to match other countries' tariffs, taxes, and non-tariff barriers. The memo does not set a hard deadline but implies the plan would not come before April 1 and no later than August.

ACTIVITY: In the UK, GDP for 4Q 2024 grew by 0.1% quarter-over-quarter, above consensus expectations for -0.1%. The quarterly expenditure breakdown was somewhat weaker, with household consumption stagnating and business investment declining notably.



MONTH-TO-DATE, AS OF 02/14/25




YEAR-TO-DATE, AS OF 02/14/25




MSCI WORLD INDEX SECTOR RETURNS


